2. **Technical issue: Course Transfer ONLY!**

If Applicant unable to attend the course due to technical issue (Wi-Fi problems), WT may approve the Applicant to attend next scheduled education without further charge of fee. (One-time ONLY) Requests MUST be made from the beginning of his/her registration program to end of 1st day of the program via email (**VERBAL requests are NOT accepted**) to WT education dept.: education@worldtaekwondo.org

3. **Bank Transfer to WT: Course Transfer ONLY!**

If Applicant made a bank transfer to WT for the registration: it is NOT eligible for a refund (NO EXCEPTIONS) but Applicant MAY eligible for a transfer to next scheduled program if Applicant notify us their desire to transfer IN WRITING by no later than the registration deadline of his/her registered program. 8. Remark:

Participants are required to watch pre-recorded videos, and need to join for “Live-webinar” through GMS on December 17, 2022 for the education and evaluation Test.

The coaches who have successfully passed the course will be granted WT [Level 1] Coach Certificate issued from online courses through GMS, which is mandatory for officiating at Sporting events from January 1, 2021.

When joining the WT ONLINE Coach Certification Course Webinar via zoom, please be aware **GOOGLE CHROME** is the only browser that will allow you to join the computer audio.
